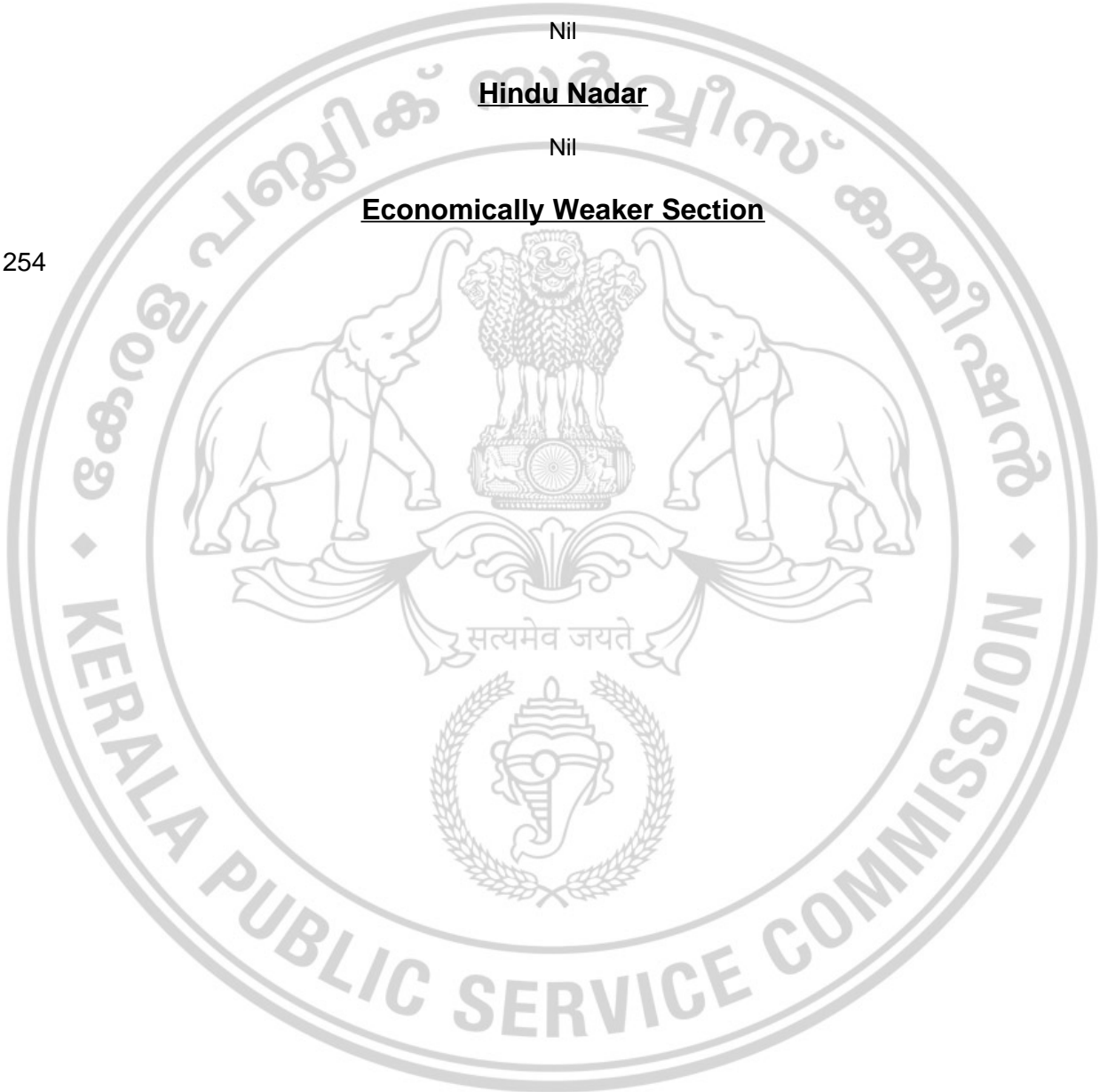

For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes,Scheduled Tribes, Other Backward Classes (and other reserved categories, if any) necessary supplementary lists have been prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. **Date,time and Venue of OTR Verification and interview will be intimated through SMS and Profile Message.**

Note :- (5) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dated. 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Copy of answer scripts of the Common OMR Test held on 17.11.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee only after publication of all the Ranked Lists of those posts for which the candidate has participated. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER16-3/2026-KPSC, Dated : 19-01-2026.**
