Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The Short list is prepared by including the number of eligible and qualified candidates who have secured top marks in the OMR Test held on 15.11.2025, based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage of selection.

Note :- (3) 29 (Twenty Nine) candidates who have secured top most marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **52.33 (Fifty Two (Point) Three Three)** marks. For the purpose of satisfying the rules of reservation of appointment to Schedule Castes, Scheduled Tribes, Other backward classes (and other reserved categories if any) necessary supplementary list is prepared by including all eligible and qualified candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) At the next stages of selection process, there will be a Practical Test for the candidates included in this list. Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification and Practical Test will be published shortly.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who are eligible for reservation are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD dated. 26.09.2009 or that obtained through e-district project in the format prescribed in GO(Rt) No.3942/2018/RD dated, 24.09.2018 and SC/ST Candidates are required to produce Community Certificate (Form III or Digitally signed) issued by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note:- (7) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note:- (8) Copy of answer scripts of the OMR Test held on 15-11-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after the publication of the Ranked List. No Answer scripts are invalidated as per Notification No :**ER 2-3/1/2026-KPSC dated: 28/01/2026.**
