Note 3. **77 (Seventy Seven)** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **57.14 Marks(Fifty Seven (point) One Four)**. For the purpose of satisfying the rules of reservation of Appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note 4. Candidates included in the Short List should be present in person for Endurance Test with the Original ID Proof and Admission Ticket and Medical certificate . Date, Time and Venue of Endurance Test will be published in due course.

Note 5. According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note 6. **SC/ST** candidates included in the Short List are required to produce Community Certificate (in Form III /Digitally Signed) issued by the concerned Revenue Authority, Candidates belonging to Other Reservation Groups should produce Non Creamy Layer Certificate issued by Village Officer and Candidates who belonging to EWS category should produce EWS Certificate issued by Village Officer at the time of OTR Verification.

Note 7. Copy of Answer Scripts of the OMR Test held on **20.12.2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note 8. Candidates whose Register Numbers are invalidated are advised to refer to Notifications No:ER16-1/1/2026-KPSC DATED:02/03/2026.
