The following is the list of candidates for selection to the post of Fire and Rescue Officer (Driver)(Trainee)(I NCA-SCCC) on Rs. 27,900-63,700/- in Fire and Rescue Services, found suitable by the Commission and arranged in the order of merit, based on the OMR Test held on 15.07.2025 , physical measurement & physical efficiency test held from 02.12.2025 to 05.12.2025 and practical test (T-test + Driving Test) held from 16.02.2026 to 23.02.2026 for the recruitment against NCA vacancies of SCCC community. This Ranked List is brought into force with effect from 30.03.2026.

The Ranked List will be valid until candidates are advised and appointed against the vacancy earmarked for the above mentioned community, but remain unfilled due to the paucity of candidates during the currency of the Ranked List No.325/2023/ER XIII published on 16.05.2023.(Cat.No. 036/2020).

NOTE (1) :- Since a common OMR Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.

NOTE (2) :- According to the existing procedure, revaluation of Answer Script is not allowed. But answer scripts will be rechecked if the candidates apply only through their One Time Registration profile from the Commission's official Website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission. (i.e. on or before 18.04.2026) The candidates can avail only one chance after the approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Fee once remitted will not be refunded. Applications submitted through email/by post/in person will not be considered.

NOTE (3) :- Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (i.e. on or before 18.04.2026). Application submitted in any other manner will not be considered. A copy of the answersheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Printout of the answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Printout of the answer sheet will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test. Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the copy of OMR Answer sheets will be provided only after the publication of all Ranked Lists of those posts for which the candidate has participated.

NOTE (4) :- The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents.

NOTE (5) :- Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to THE SECRETARY, KERALA PUBLIC SERVICE COMMISSION, PATTOM, THIRUVANANTHAPURAM-695004. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of last Ranked list included in the common OMR test held on 15.07.2025.
