NOTE (1) :- For Online Examination **rechecking** and **reevaluation** are **not allowed**. Candidates who wish to obtain a printout of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed **fee of Rs.335(Rupees three hundred and thirty five only)** via **e-payment** mode available in the portal. A period of **15 (Fifteen)days** time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Application submitted in any other manner (i.e via e.mail/Tappal/Direct) will not be considered. A Printout of the answer sheet will be issued only once to a candidate after the publication of the Ranked List for all the posts finalised on the basis of the common Online Examination.

NOTE (2) :- Any candidate can relinquish his/her right for appointment in writing addressed to the post of The District Officer, Kerala Public Service Commission District Office, Kasaragod 671121, in the format prescribed by the Commission duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. "The Candidates who wish to relinquish their claim for advice from the Ranked list shall submit an Application in the format prescribed by the Commission. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the Relinquishment Application in the format prescribed by the Commission will not be honoured under any Circumstances". The request for **relinquishment** received within **15 days** from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. In the case of the requisition of vacancies received after the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (3) :- **Since a common Online Examination with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of all candidates appeared for the Online Exam will be published only after the publication of entire Ranked Lists (including NCA selections) which will be finalised on the basis of the common test.**

NOTE (4) :- **Inclusion of GNM / B Sc Nursing qualified candidates in the list and any appointment made shall be subject to the result of OP(KAT) 253/21 and SLP(C) No. 13242/21.**
