The following is the list of candidates for selection to the post of **WOMEN CIVIL EXCISE OFFICER (FIRST NCA FOR SCHEDULED CASTE)** on **Rs 20000-45800/-** in **EXCISE DEPARTMENT in KASARGOD District**, found suitable by the Commission and arranged in the order of merit based on Main OMR Test held on 26/02/2022 Endurance Test on 31.01.2023 and Physical Efficiency Test held on 26/05/2023 for recruitment against the NCA vacancies for SC only. This NCA Ranked List is brought into force with effect from 02/08/2023, and will be valid until the candidates are advised and appointed against the vacancies earmarked for Scheduled Caste Community, but remain unfilled due to paucity of candidates during the currency of the Mother Ranked list published on 04/05/2015 (Cat.No.261/2014) for the post.

Note(1):- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their One Time Registration profile from Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Eighty Five only). The fee can be remitted by epayment through the portal. Applications submitted in any other manner will (ie, via email/Tappal/Direct) not be considered. A period of 15(Fifteen) days time to apply for rechecking of **Answer Scripts will be allowed to candidates with effect from the Date on which the Ranked List is uploaded in the website of the Commission(on or before 22.08.2023.).**

NOTE (2) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their one time registration profile from the official website of the Commission , www.keralapsc.gov.in by remitting the prescribed Fee of Rs. 335/- (Rupees Three Hundred and thirty five only) via e - payment mode available in the portal. A period of 15(Fifteen) days time (ie, on or before 22.08.2023.)to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Application submitted in any other manner(ie, via email/Tappal/Direct)will not be considered. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for printout of the answer sheet which is not their own and legal proceedings will be initiated against those who do so. Printout of the answer sheet will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test. Copies of answer sheets invalidated due to any defect will not be issued.

NOTE (4) :-The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to District Officer, Kerala Public Service Commission District Office, Kasaragod. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

NOTE (5) :- Since a common OMR Test with common candidates was conducted for this post,the marks awarded to the candidates included in the Ranked list and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of the entire ranked list which will be finalized on the basis of common test.The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer scripts will be issued only after the publication of the ranked list for all posts finalized on the basis of common test.

NOTE(6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalization of all Ranked list included in the common OMR test held on 26/02/2022.
