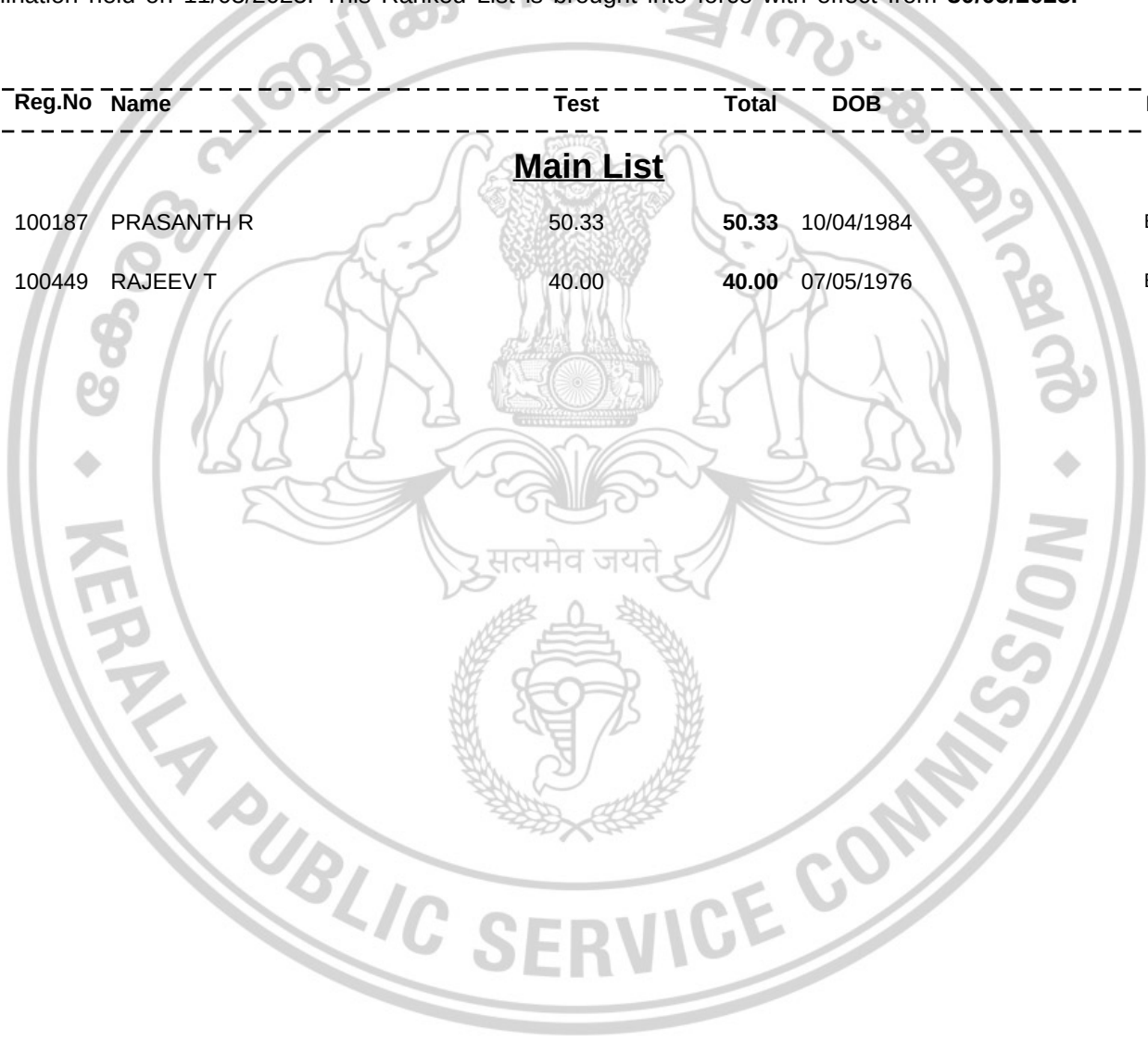
NOTIFICATION

NOTE (1) :- Candidates from the Ranked List will be advised for appointment against 10% of vacancies which are reported to the Commission for the post of Clerk Ex-Servicemen only in the NCC/ Sainik welfare Departments in Kollam District during the pendency of the Ranked List. The rules regarding the reservation of appointment as contemplated in the Rules 14 to 17 of Part II of the Kerala State and Subordinate Service Rules, 1958 are not applicable to appointment By Transfer. If sufficient number of candidates are not available to fill up the 10% reservation quota mentioned above, such vacancies will be filled up by candidates included in the Ranked List prepared for open quota. In case candidates included in the Ranked List prepared for recruitment By Transfer could not secure appointment before the expiry of the Ranked List, the names of such candidates will be included at the top of the new ranked list of the low paid employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly.

NOTE (2) :- For Online Examination rechecking and revaluation are not allowed. Candidates who wish to obtain a printout of their answer sheets relating to this selection shall submit online application through their One Time Registration Profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Application submitted in any other manner (i.e. via email/ Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Printout of the answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Printout of the answer sheet will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE(3):- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission addressed to the District Officer, Kerala Public Service Commission, District Office, Kollam-691001 either directly or by post. The format is available in the Official website of the Commission. Those who do not submit the relinquishment application in the format prescribed by the Commission, will not be honoured under any circumstances. The request for relinquishment should be duly attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested Copy of an ID Proof bearing Photograph as enlisted in the General Conditions. The request for relinquishment, along with the original Notarized affidavit and self attested copy of an ID proof received within 15 days from the date of uploading of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (4):- Since a Common Online test with Common candidates was conducted to this Post, the mark awarded to the candidates included in the Ranked List and mark of online test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notification) which will be finalized on the basis of the common test.

EX-Ex-Servicemen, Willing:- Willing for Security post like Store keeper, Cashier etc for which Fidelity Guarantee policies are required.
