NOTE (1) :- The Ranked List will be in force till the publication of a new Ranked List after the expiry of minimum period of one year or till the expiry of three years whichever is earlier. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List. **The rules regarding the reservation of appointment contemplated in the Rules 14 to 17 of Part II of the KS & SSR, 1958 are not applicable to appointment By Transfer.**

NOTE (2) :- For Online Examination rechecking and revaluation are not allowed . Candidates who wish to obtain a printout of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of **Rs. 335(Rupees three hundred and thirty five)** via e-payment mode available in the portal. **A period of 15 (Fifteen) days time to apply for printout** of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie ,on or before **13/11/2025**). Application submitted in any other manner (i.e. via email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Printout of the answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Please note that in the case of Ranked Lists of those Posts for which Common Examinations were conducted, Printout of the answer sheet will be issued only after the publication of all Ranked Lists of those posts for which the candidate has participated.

NOTE (3) :- Since a common Online Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of Online test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be on the basis of the common test.

NOTE (4) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to the **District Officer , Kerala Public Service Commission, Thrissur- 680020**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. After the publication of the Ranked List the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
