Note:- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note:- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be published shortly.

Note:- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 /GO(Ms) No.5/2020/P&EA dated 04.03.2020 (for public sector undertaking) issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (7) Copy of answer scripts of the OMR Test held on 27-04-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts of the candidates were invalidated as per Notification No : ER16-2/5/2026-KPSC Dated 18/06/2026
