Note :-

- (i) Conventional type application will be summarily rejected. Candidates shall apply only through online application available at the Kerala Public Service Commission website 'www.keralapsc.gov.in' .
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iii) Separate ranked lists will be prepared for the above communities in the above district in pursuance of this notification. Ranked Lists thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv) The candidates belonging to above reservation communities shall submit application for this post to pathanamthitta district where the vacancy is existing for their respective community and shall note the name of that district against the relevant column in the online application. Applications should not be submitted to more than one district in response to this notification.
- (v) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961. Candidates already in Government

service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (From candidates belonging to above reservation communities only).
6. Age limit
- 1) 18 – 42. Viswakarma candidates born between 02.01.1974 and 01.01.1998 (both dates included) are eligible to apply for this post . [Including the relaxation as per para 2 (i) of General Conditions].
- 2) 18 – 44. ST candidates born between 02.01.1972 and 01.01.1998 (both dates included) are eligible to apply for this post .[Including the relaxation as per para 2 (i) of General Conditions].

Note: For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years. Please see para (2) of the General Conditions under Part II of this notification [except para 2 (i)].

7. Qualifications:-

- (i) A Pass in Standard VII/III Forum.
- (ii) Must possess valid Driving Licence of three years standing to drive Light Motor Vehicle with Driver's badge.
- (iii) Proficiency in Driving light Motor Vehicles which is to be proved in a practical test (including H test) conducted by KPSC during the course of selection. Only those who pass 'H' test are eligible for Road Test.

Note:- Rule 10 (a) ii of Part II of KS&SSR is applicable.

- (c) Muscles and joints : No paralysis, all joints must be capable of free movement.
- (d) Nervous System : Perfectly normal and free from any infectious diseases.

Note :-

- 1 Candidates called for practical Test will have to produce a Medical Certificate in the prescribed form in original containing all relevant details as required in para 7(iv) (except iv(b) above from a Medical Officer not below the rank of an Assistant Surgeon. A Medical certificate regarding eye sight in Para 7 (iv)(b) from a Ophthalmologist in Government Service also will have to be produced.
- 2 The Candidates will have to furnish the full details regarding the Driving Licence and experience in driving in the relevant column (qualifications) of the application form.
- 3 Differently abled candidates are not eligible to apply for the post.

- 4 Candidates should possess a current valid Driving Licence and badge through out all the stages of selection process i.e on the last date of receipt of application, OMR test and on the date of Practical Test, interview etc.
- 5 Candidates included in the Ranked list in pursuance of notification shall be advised against Head Quarter vacancies also if their turn arises.



8. **Mode of Submitting Applications:-**

Candidates must register as per " ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID

and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
