- (i) Conventional type applications will be summarily rejected. Candidates shall apply only through online application available at the Kerala Public Service Commission website viz <u>www.keralapsc.gov.in</u>.
- (ii) Separate Ranked list will be prepared for each district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject

to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case not candidate is advised from the ranked list till expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

- (iii) Applications should not be sent to more than one district in response to this notification. If applications are send contrary to the above direction and if he/she is selected his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Candidates should submit the application for this post to the concerned district office and should note the name of that district against the relevant column in the applications.
