Applications are invited Online only by “ONE TIME REGISTRATION” from qualified candidates belonging to reservation group of community of Kerala State viz Muslim for appointment in the under mentioned post in Kerala Government Service.

1. **Department** : Technical Education (Polytechnics)
2. **Name of Post** : Head of Section (Computer Engineering)
3. **Scale of pay** : ₹ 12930-20250 (PR)
4. **Number of vacancy** : Muslim - 1 One)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for Muslim community but remain unfilled due to the paucity of candidates belonging to Muslim Community during the currency of the Ranked list published on 11.11.2009 for the post (Category No. 328/2008, Gazette Date 27.09.2008)

5. **Method of appointment** : **Direct Recruitment** (From among candidates belonging to the Muslim Community).

NOTE: Applications of candidates belonging to communities other than Muslim will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

6. **Age Limit** : **20-44** [Only candidates born between 02.01.1972 and 01.01.1996 (both dates included) are eligible to apply.

(Including the relaxation as per Para 2(i) of the general condition)

Note : For other conditions regarding age relaxations, please see Para (2) except para 2(i) of part 2 of the General conditions.

7. Qualifications

- 1 Degree in Computer Engineering/Technology or any other qualification recognised by Government as equivalent there to with not less than 60%

marks in the qualifying examination.

- 2 8 years experience in Engineering profession of which atleast 3 years should be teaching experience in the subject as Lecturer not below Diploma Level in recognised/approved Institution.

Note : 1. Rule 10 (a) (ii) of Part II KS & SSR is applicable.

2. Diploma in Computer Engineering/Technology obtained after undergoing a regular course of study for not less than 3 years with 60% marks in the qualifying examinations and a pass in section A and B of AMIE will be considered as equivalent to Degree in Computer Engineering/Technology.
3. In the case of First or Second Class Post Graduate Degree holders in Computer Engineering/Technology, the prescribed 60% marks in the concerned branch for the basic degree will not be insisted upon

The total marks of all the Years/Semesters of the course in which University Examinations are conducted shall be taken into account in calculating the 60% marks.

4. Percentage of marks obtained for the above mentioned examinations, details of experience and name of the branch of Engineering/Technology should be furnished in the column prescribed for noting qualification for the post in the application.
5. Experience claimed by the candidates shall be the one gained after acquiring the basic qualification for the post
6. The veracity of the Experience Certificate will be subjected to scrutiny and those who issue or produce bogus certificate will be subjected to legal proceedings. 8. Mode of submitting Applications:

Candidates must register as per "ONE TIME REGISTRATION" with the Official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply now' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall

take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote User-Id for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, age etc have to be produced as and when called for.
