SECOND NCA NOTIFICATION

Applications are invited Online only from qualified candidates of Muslim Community of Kerala State for appointment in the undermentioned post in Kerala Government Service. Before applying for the post the candidates shall register as per One Time Registration scheme through the official website of Kerala Public Service Commission. This is the II NCA notification due to the non availability of Muslim candidates for the post as per first NCA notification dated 11.04.2014 (category No. 71/2014).

- 1. Department** : Vocational Higher Secondary Education
- 2. Name of post** : Vocational Teacher in Cosmetology and Beauty Parlour Management
- 3. Scale of pay** : ₹ 19240 – 34500
- 4. Number of vacancy** : 1 (One) (Muslim)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the above vacancy earmarked for Muslim Community, but remain unfilled due to paucity of candidates during the currency of the ranked list published on 14.01.2008.

- 5. Method of appointment** : Direct Recruitment (from among Muslim community only)

Note :- The applications submitted by candidates other than Muslim community will be summarily rejected. No rejection memo will be issued to those candidates.

- 6. Age limit** : 23-43. Only candidates born between 02.01.1972 and 01.01.1992 (both dates included) are eligible to apply for this post. [For conditions regarding the age relaxations, please see Para 2 of the General Conditions except para 2 (i)]

7. Qualifications :-

Post Graduate Degree in any branch with not less than 50% marks awarded by any of the Universities in Kerala or an equivalent qualification with certificate (Minimum One Year

duration) in Cosmetology and Beauty parlour Management from a Government recognized Institution.

- Note :-
1. In the appointment of Vocational Teacher preference will be given to persons having additional qualification of Diploma in Computer Application from a recognised Institution.
 2. All the Educational qualifications for teaching posts should be one acquired after a regular course of study from a recognised University in Kerala or recognised as equivalent there to by any of the Universities in Kerala.
 3. Rule 10(a)(ii) of Part II of KS&SSR is applicable

8. Method of submitting Applications :-

Before applying for the post, candidates shall register as per 'ONE TIME REGISTRATION' scheme through the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in'. Candidates are responsible to ensure correctness of the personal information and secrecy of password and they shall keep in mind the User Id for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove Qualification, experience, community age etc have to be produced as and when called for.
