Applications are invited online only by One Time Registration from qualified candidates belonging to OX community for the under mentioned post.

1. Department : Education
2. Name of Post : High School Assistant (Kannada)
3. Scale of pay : ₹ 15,380-25,900/-
4. No. of vacancies : District wise
OX – Kasaragod – 1 (One)

Note:-

- (i) Conventional type applications will be summarily rejected. Candidates shall apply online only to www.keralapsc.gov.in.
- (ii) Applications submitted by candidates belonging to the community other than those notified will be summarily rejected. No rejection memo will be issued.
- (iii) Separate Ranked lists will be prepared for Kasaragod district in pursuance of this notification. Ranked Lists thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following districts.

- (iv) Application shall be sent to Kasaragod district only in response to this notification.
 - (v) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
5. Method of appointment : Direct Recruitment (from candidates belonging to , OX community only).

6. Age Limit : 18-43. Only candidates born between 02.01.1972 and 01.01.1997 (Both dates included) are eligible to apply for this post. [Including the relaxation as per Para 2(i) of General Conditions].

Note:-

- (i) In the case of adult members of Scheduled caste converted to OX and their children, the upper age limit will be 45 years (i.e between 1.1.1997 and 2.1.1970).
- (ii) For conditions regarding other age relaxation please see para 2 of the general conditions except Para 2 (i).

7. Qualification:

A Degree in Kannada and B.Ed/B.T/L.T conferred or recognised by the Universities in Kerala.

OR

A Title of Oriental Learning in Kannada awarded or recognized by the Universities in Kerala. (If such Title has been declared as equivalent to Part III of Degree) and Certificate in Language Teacher's Training issued by the Commissioner for Government Examinations, Kerala.

Note:-

- (i) Post Graduates in Kannada are also eligible to apply for this post provided that they have B.Ed/B.T/L.T qualification.
- (ii) B.Ed should be in the concerned subject i.e Kannada.
- (iii) Disciplines in which BA/MA and B.Ed degree were obtained should be mentioned in brackets.
- (iv) Those candidates who secured BA/MA and B.Ed/BT Degree from the Universities outside Kerala should note in the application form, the number and date of relevant orders declaring the said degree as equivalent to those prescribed for this selection.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the terms `Jawans'. Wives of Jawans should select 'Are you entitle to any priority' as 'yes' on online application and give the details in the space that follows. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).
- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975 and GO (MS) No 50/70/PD dated 12.02.1970.

- (iii) Teachers of the Government Primary and Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit (G.O (Ms) No 185/70/Edn dated 18.4.1970 and G.O (Ms) No 466/70/Edn dt 11.11.1970). They should produce proper certificates from authorities concerned as and when required by the Commission.

Note:- The candidates who claim concessions by virtue of the above or any of the reason mentioned in Para 2 of the General Condition should state “Are you eligible for age relaxation” as “yes” on the online application and give details in the space following otherwise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (see para 2 of General Conditions).

9. Last Date for receipt of applications **04.11.2015 Wednesday upto 12.00 Midnight.**

10. Mode of Sending Application :

Candidates must register as per “ ONE TIME REGISTRATION” on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in'. Those who have registered shall apply by logging on to their profile using their user ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link **Registration Card**. Candidates are responsible for the correctness of the personal information and secrecy of password. Before final submission of application, candidates must ensure correctness of the information in their profile and they shall quote the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.

12. If a Written Test/OMR Test is conducted as part of the selection, Admission Ticket of eligible candidates will be made available in the website of the Kerala Public Service Commission. Candidates are instructed to download their Admission Ticket as per the instructions in the website.
