Note:-

- (i) Conventional type applications for the above post will be summarily rejected. Candidates can apply online only by One Time Registration on www.keralapsc.gov.in
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.
- (iii) Separate Ranked lists will be prepared for each district and community in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following districts.

- (iv) The candidates belonging to above reservation community shall submit application for this post to the district concerned where the vacancy is in existence for their respective community and shall note the name of that district against the relevant column in the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (v) The selection in pursuance of this notification will be made on a revenue district basis,

subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked

List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of Appointment : Direct Recruitment (from the above mentioned reservation group of communities only). In the absence of Scheduled caste candidates, the candidates belonging to Scheduled Tribe community will be considered.
6. Age Limit
- (i) 18 – 43. Only candidates born between 02.01.1972 and 01.01.1997 (both dates included) are eligible to apply for this post in the case of Latin Catholic/AI, SIUC Nadar/AI, Hindu Nadar & Viswakarma communities.
- (ii) 18 – 45. Only candidates born between 02.01.1970 and 01.01.1997 (both dates included) are eligible to apply for this post in the case of Scheduled Caste candidates [Including the relaxation as per para 2 (i) of General Conditions].

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification except para 2 (i).

7. Qualifications :-

- (1) S.S.L.C or its equivalent qualification.

And

- (2) Degree in Urdu conferred or recognized by the Universities in Kerala.

OR

A Title of Oriental Learning in Urdu awarded or recognized by the Universities in Kerala.

OR

A Pass in Adib-I-Fazil (Preliminary) Examination in Urdu conducted by anyone of the Universities in Kerala.

OR

A Pass in Urdu Higher Examination conducted by the Commissioner for Government Examinations, Kerala.

Notes :-

- (i) Disciplines in which BA/Title of oriental learning obtained should be mentioned in the application.

- (ii) Those candidates who have secured BA/Title of oriental learning from the Universities outside Kerala should note in the application form, the number and date of relevant orders from any of the universities in Kerala recognising the said degree as equivalent to those prescribed for this selection. The copies of such order shall be produced before the commission when it is called for.

Note: Rule 10 a (ii) of KS & SSR will be applicable for this post.

8. Special concessions regarding Appointment and age limit :-

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term 'Jawans'. Wives of Jawans should select "Are you entitled to any priority" as yes on the online application and give the details in the space following. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).
- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975 and GO (MS No 50/70/PD dt 12.2.1970).

Note:- The candidates who claim concessions by virtue of the above or any reason mentioned in Para 2 of the General Condition should state "Are you eligible for age relaxation" as "yes" on the online application and give details in the space following otherwise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (see para 2 of General Conditions).

9. Mode of Sending Application :-

Candidates must register as per "ONE TIME REGISTRATION" on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in'. Those who have already registered shall apply by logging on to their profile using their user ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile and they shall quote the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove qualification, community, age etc. have to be produced as and when called for.

10. Last Date for receipt of applications : **04.11.2015 Wednesday upto 12.00 Midnight.**
