**FIRST NCA NOTIFICATION**

Applications with photo uploaded are invited only from qualified candidates belonging to reservation groups of the Scheduled Tribes community only in Kerala State for appointment in the under mentioned post in Kerala Government Service. Candidates should register through 'ONE TIME REGISTRATION' scheme before applying for the post.

- 1. Department** : **Higher Secondary Education**
- 2. Name of Post** : **Higher Secondary School Teacher ( Senior) English**
- 3. Scale of pay** : **₹ 20740 – 36140/- (Revised)**
- 4. Number of vacancies** : **Scheduled Tribes – 3 (Three)**

The above vacancies are now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the Scheduled Tribes but remains unfilled due to the paucity of candidates during the currency of the ranked list published for the post with effect from 11.12.2013 (Category No. 110/ 2010 Gazette date 30.04.2010)

- 5. Method of appointment** : Direct Recruitment (from candidates belonging to Scheduled Tribes.)

Note : The applications of candidates belonging to other than Scheduled Tribes will be summarily rejected. Individual rejection memo will not be sent.

- 6. Age limit** : 20-45. Only candidates born between 02.01.1971 and 01.01.1996 (both dates included) are eligible to apply for the post. (Including relaxations in para 2(i) of the General Conditions) (For other conditions regarding age relaxation, please see Para (2) of the general conditions except Para 2 (i).)

**7. Qualifications**

1. Master's Degree in the concerned subject with not less than 50% marks from any of the Universities in Kerala or a qualification recognized as equivalent thereto in the respective subject by any University in Kerala.
2. (i) B.Ed in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any University in Kerala.  
(ii) In the absence of persons with B.Ed. Degree in the concerned subject, B.Ed Degree acquired in the concerned faculty as specified in the Acts and Statues of any of the Universities in Kerala.  
(iii) In the absence of persons with B.Ed. Degree as specified in item (i) and (ii) above, persons with B.Ed. Degree in any subject acquired after a regular

course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala

3. Must have passed the State Eligibility Test for the post of Higher Secondary School Teacher conducted by the Government of Kerala or by the agency authorized by the State Government.

- Note :
1. In the absence of B.Ed Degree holders, candidates having Masters Degree with not less than 50% marks and who have passed the State Eligibility Test will be considered. Preference will be given to those who have acquired Ph.D/M.Phil. Degree or qualified at Junior Research Fellowship/National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed Degree at their own expense within five years from the date of entry in service.
  2. Those who have passed Language Teachers training Course are exempted from acquiring B.Ed. qualification.
  3. Persons who have acquired M.Ed in the subject concerned recognized by any University in Kerala are exempted from B.Ed qualification.
  4. KS&SSR Part II, Rule 10(a)(ii) is applicable.

### **Exemptions**

1. Those persons who have passed the State Level Eligibility Test for post of College Lecturers conducted by Government of Kerala are exempted from passing the the State Eligibility Test for Higher Secondary School Teacher.
2. Those persons who have passed National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
3. Persons with Ph.D/M.Phil/M.Ed. degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be the one awarded by any of the Universities in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.
4. The teachers who have completed 10(ten) years of approved Teaching Service at the High School level in the General Education subordinate service shall be exempted from passing the State Eligibility Test for Higher Secondary School Teacher.

### **8. Mode of submitting Applications:-**

Before applying for the post, candidates shall register as per 'ONE TIME REGISTRATION' through the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)'. Those who have already registered shall apply by logging in to their profile using his/her User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. The photograph uploaded should be one taken on or after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of

photographs No application fee is required. Candidates can view, rectify defects and have print - outs of the details in the Profile by clicking the link Registration Card after entering the Home Page. . Candidates are responsible for the correctness of the personal information and secrecy of password and they must quote the User ID for further communication with the Commission. Before the final submission of application on the profile, candidates must ensure the correctness of the information on their profile. Applications once submitted will be received as provisional and the particulars shall not be deleted or altered after submission. Applications which are submitted not in accordance with the instructions given on the notification and website will be summarily rejected. Documents to prove qualification, service, age, community etc. have to be produced as and when called for.

If a Written/OMR Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
