The copy of answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 08.12.2017. Applications received after the prescribed date will not be entertained.
- Note (2):- A period of 45 (forty five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this ranked list is brought into force. The candidates can avail only one chance "Applications for rechecking of answer scripts should be

submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied there from. Applications submitted in any other manner will not be considered." The application for rechecking, along with the original chalan receipt for the prescribed fee of ₹75/- under the head of account "0051-PSC 105 StatePSC 99-Examination Fee", addressed to DEPUTY SECRETARY (EXAMINATIONS II), KERALA PUBLIC SERVICE COMMISSION, PATTOM P.O., THIRUVANANTHAPURAM 695004, should reach the office on or before 08.12.2017. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

- Note (3):- "Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of the State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of ranked list. After the publication of ranked list, the request for relinquishment will be considered only if such request is received on or before the date of reciept of requisition based on which he/she is to be advised."
- Note (4):- The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalisation of Ranked list i.e. on **24.04.2018**.
- Note (5):- Since a common dictation test with common candidates was conducted for this post, the marks awarded to the candidates will be published only after the publication of entire Ranked list which will be finalised on the basis of the common test.
