Applications are invited online only through One Time Registration from qualified candidates for appointment in the undermentioned post in Kerala Government Service.

1.	Department	:	Health Services
2.	Name of Post	:	General Physiotherapist
3.	Scale of pay	:	Rs.32300-68700/-
4.	Number of vacancies	:	06 (Six)

The above vacancies are now in existence. The Ranked list published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies reported to the Commission in writing during the period of currency of the list.

5.Method of appointment:Direct Recruitment

6.Age limit:18-36, only candidates born between **02/01/1982** and **01/01/2000** are eligible to apply for this post

(For conditions regarding age relaxation please see Para 2 of the General Condition)

7.Qualifications:

I) A Bachelor's Degree in Physiotherapy

OR

II)a)Pass in Pre-University Examination or Pre-Degree Examination or its equivalent

b)Diploma in Physiotherapy from an institution recognized by State Government

OR

c)Training given to Physiotherapist Assistant Class II of Armed Forces

Note I: Preference will be given to those with Bachelor's Degree in Physiotherapy.

Note II:Candidates who claim equivalent qualifications instead of qualification mentioned in the Notification shall produce the relevant Government Order to prove the equivalency at the time of verification ,then only such qualifications shall be treated as equivalent to the prescribed qualification.

Note III:In the case of difference in original Caste / Community claimed in the application and that entered in S.S.L.C book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate / Community Certificate at the time of Certificate Verification.

Note IV:Rule 10(a) (ii) of part II KS&SSR is applicable.

8.Mode of submitting Application:

a) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10

years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for.

b) If a Written / OMR / Online Test is conducted as part of this selection, candidates shall submit a confirmation on writing the examination through their profiles for One Time Registration. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.

c) Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
