**NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 18.04.2012 and the verification of original documents of candidates included in the Probability List published on 14.02.2013 for selection to the post of **Last Grade Servants(SR for SC/ST only)** on ` **4510 - 6230/-** (PR) in **Various Departments** in **MALAPPURAM DISTRICT** (**Category No.123/2011**) arranged in the order of merit.

The Ranked List is brought into force with effect from **05.04.2013**. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. Answer scripts will be rechecked to see that all the answers are valued and that there is no mistakes in totaling of marks for various answers. Re-checking of answer scripts, will be done on payment of ` **50** (Rupees Fifty only). The fee should be remitted in any one of the Treasuries in the state by chalan under the Head of Account "**0051- PSC- 105- STATE PSC- 99 EXAMINATION FEE**". The fee once remitted will not be refunded on any account. The result of the re-checking will be intimated to the candidates from this office. Application for re-checking of answer script should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopies there from. Applications submitted in any other manner will not be considered.

Candidates who wish to obtain the photocopy of their OMR answer script (Part A & Part B) relating to this selection should remit the prescribed fee of ` **200/-** (Rupees Two hundred only) in any one of the Treasuries in the State under the **Head of Account: "0051-PSC-800 Other Receipts-99-other receipts"**. The duly filled in application in the prescribed form (available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chalan should be submitted to **The District Officer, Kerala Public Service Commission District Office, Civil Station, Malappuram**. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of

an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for re-checking / obtaining photocopy of answer scripts addressed to **The District Officer, Kerala Public Service Commission District Office, Civil Station, Malappuram** shall reach this office within 45 days from the date on which the Ranked List has come into force (ie, the date on which the Ranked List has been approved by the Commission). The last date for receipt of applications for re-checking / obtaining photocopy of the answer script is **20.05.2013**. Application for re-checking / obtaining photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries put in column 8 (community) are based on the communities specified by the candidates in their applications and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to **The District Officer, Kerala Public Service Commission District Office, Civil Station, Malappuram** within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.

Letter '**M**' should be prefixed to the Register Number to denote Malappuram District.

Note: Weightage marks for nativity will be granted subject to the final order in WA 618/2012.
