NOTIFICATION

The following list contains the names of candidates found suitable by the commission on the basis of the result of the Objective Type (OMR) Test held on **24-02-2011** and followed by a Physical Measurement and Practical Test held on 02-11-2012 for selection to the post of SEAMAN (NCA-LC, Muslim) **on Rs. 5250-8390 in PORT Department in Kozhikode District** arranged in the order of merit. The Ranked List is brought into force with effect from **22-04-2013**. The Ranked List will be in force until the candidates are advised and appointed against the vacancies earmarked for LC and Muslim communities, but remain unfilled due to the paucity of candidate during the currency of the Ranked List published for the post on 26-04-2007 in Kozhikode District.

All the candidates participated in the Practical Test were included in the Ranked List for the above post.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs.50/- (Rupees Fifty only). The fee should be remitted in any one of the Treasuries in the State under the Head of Account "**0051 PSC 105 STATE PSC- 99 EXAMINATION FEE**". Application for re-checking of answer script should be submitted in the prescribed form downloaded from the commission's website www.keralapsc.gov.in or photocopied there from . Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the District Officer, KPSC District Office, Civil Station, Kozhikode within 45 days from the date on which this Ranked List is published by the Public Service Commission. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain photocopy of their Answer Sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs.200/-(Rupees Two hundred only)** by way of chalan in any one of the Treasuries in the State (Head of Account "0051-PSC-800 STATE PSC-99-Other receipts"). The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Civil Station, Kozhikode**. Copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/obtaining photocopy of Answer Script addressed to district Officer, KPSC District Office, Civil Station, Kozhikode shall reach this office within 45 days from the date on which the Ranked List has come into force (ie, the date on which the ranked List has been approved by the Commission).

The last date for receipt of applications for rechecking/obtaining photocopy of Answer Script is 05-06-2013. Application for rechecking/obtaining photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
