The fee should be remitted in any one of the Treasuries in the state by chalan under the Head of Account "**0051- PSC- 105-STATE PSC- 99 EXAMINATION FEE**". The fee once remitted will not be refunded on any account. The result of the re-checking will be intimated to the candidates from this office. Application for re-checking of answer script should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.org or photocopies there from. Applications submitted in any other manner will not be considered.

Candidates who wish to obtain the photocopy of their OMR answer script (Part A & Part B) relating to this selection should remit the prescribed fee of ` 200/- (Rupees Two hundred only) in any one of the Treasuries in the State under the <u>Head of Account:</u> "0051-PSC-800 Other Receipts-99-other receipts". The duly filled in application in the prescribed form (available from the Commission's website <u>www.keralapsc.org</u>) along with the original chalan should be submitted to <u>The District Officer, Kerala Public</u> Service Commission District Office, Civil Station, Malappuram. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against
