NOTIFICATION

The following is the Ranked list of candidates for selection to the Post of **LD Typist/Typist Clerk/Clerk Typist(SR for PH)** in various Departments in Palakkad District, notified in the Gazette dated 30-4-2012 on **Rs.9940-16580/-** found suitable by the commission and arranged in the order of merit based on the OMR Test held on 10-10-2012 and suitability assessment held on 3-4-2013. This ranked list is brought into force with effect from 20-08-2013.

The Ranked List is intended for recruitment to the 3% backlog vacancies during the period 1.1.2004 to 31.12.2007 earmarked for the various categories and PH groups as per GO(P)No.7/2011/SWD dated 24.01.2011 and will remain in force for a maximum period of three years subject to the condition that the ranked list will cease to exist as and when candidates are advised and appointed against the vacancies notified. Rules 14 to 17 of Part II, KS&SSR are not applicable to this selection.

Candidates will be advised and appointed against the vacancies notified and also against the backlog vacancies , if any, reported by the Appointing Authorities as earmarked in GO(P)No.7/11/SWD dated 24/01/2011. Candidates will be advised from the Ranked List for appointment against Head Quarters vacancies also without option.

According to the existing procedure, re-valuation of Answer Scripts is not allowed. But re-checking of marks will be done on payment of Rs. 50/-. The fee should be remitted in any one of the treasuries in the State under the head of account **“0051 PSC - 105 State PSC- 99 Examination Fee”** and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website/ www.keralapsc.gov.in / or photocopied there from. Applications submitted in any other manner will not be considered. The original challan receipt together with the application for re-checking should reach the **District Officer, K.P.S.C District Office, Civil Station Palakkad** within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account. Applications for rechecking of Answer scrips invalidated, will not be entertained.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the treasuries in the State (Head of Account **0051 PSC-800 State PSC – 99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should be submitted to the **District Officer, K.P.S.C District Office, Civil Station, Palakkad** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/ photocopy of answer script addressed to **District Officer, K.P.S.C District Office, Civil Station Palakkad** shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking / photocopy of answer script is 3.10.2013. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
