The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

Entries put in column 4 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, KPSC District Office, Civil Station, Kozhikode within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs. 50/- (Rupees Fifty only). The fee should be remitted in any one of the Treasuries in the State under the Head of Account "<u>0051 PSC 105 STATE PSC- 99 EXAMINATION FEE</u>" and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form downloaded and printed in A4 size paper from the Commission's website **www.keralapsc.gov.in** or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the Applications for re-checking should reach the **District Officer, K.P.S.C District Office, Civil Station, Kozhikode-20** within 45 days from the date on which the Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain photocopy of their OMR answer script (Part A & Part B) relating to this selection shall remit a fee of **Rs.200/-(Rupees Two hundred only)** by way of chalan in any of the Treasuries in the State under the **Head of Account:** "0051-**PSC-800 State PSC -99 other receipts"**. The duly filled up application in the prescribed form (available from the Commission's website)along with chalan should be submitted to the **District Officer, KPSC District Office, Civil Station, Kozhikode** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/ photocopy of answer script addressed to **District Officer, K.P.S.C. District Office, Civil Station, Kozhikode** – **20** shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/ photocopy of answer script is **19-10-2013.** Application for re checking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
