The candidates who have obtained **42 (Forty Two)** marks and above in the OMR test are included in the Main List of the Ranked List. The requisite marks have been lowered to the extent necessary in respect of candidates under the reservation group of communities.

According to the existing procedure, revaluation of answer scripts is not allowed. But rechecking of marks, will be done on payment of Rs.50 (Rupees Fifty only). The fee should be remitted in any one of the Treasuries in the state by chalan—under the Head of Account "0051 - PSC - 105 - STATE PSC - 99 EXAMINATION FEE". The fee once remitted will not be refunded on any account. The result of the re-checking will be intimated to the candidates from this office. Application for re-checking of answer script should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopies there from. Applications submitted in any other manner will not be considered. Candidates who wish to obtain the photocopy of their OMR answer script (Part A & Part B) relating to this selection shall remit the prescribed fee of Rs.200/- (Rupees Two hundred only) by way of chalan in any one of the Treasuries in the State under the Head of Account: "0051-PSC-800 Other Receipts-99-other receipts". The duly filled in

application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to The District Office, Civil Station, Malappuram. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Valid applications for re-checking / obtaining photocopy of answer scripts addressed to The District Office, Kerala Public Service Commission District Office, Civil Station, Malappuram shall reach this office within 45 days from the date on which the Ranked List has come into force (ie, the date on which the Ranked List has been approved by the Commission). The last date for receipt of applications for re-checking / obtaining photocopy of the answer script is 19.10.2013. Application for re-checking / obtaining photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries put in column 4 (community) are based on the communities specified by the candidates in their applications and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to **The District Officer**, **Kerala Public Service Commission District Office**, **Civil Station**, **Malappuram** within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.
