The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidate from this office. Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered. The valid applications for rechecking of answer script along with the original chalan receipt for prescribed fee addressed to the District Officer, Kerala Public Service Commission, District Office, Idukki, shall reach this office within 45 days from the date on which the ranked list has come into force, (i.e. the date on which the ranked list has been approved by the Commission).
