Applications submitted in any other manner will not be considered. The original challan receipt together with the application for re-checking should reach the District Officer, K.P.S.C District Office, Kollam within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account. Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of challan in any of the treasuries in the State (Head of Account 0051 PSC - 800 State PSC - 99 other receipts). The duly filled up application in the prescribed form (available from the Commission's website) along with the original challan should be submitted to the District Officer, K.P.S.C District Office, Kollam within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Valid applications for rechecking/ photocopy of answer script addressed to District Officer, K.P.S.C District Office, Kollam shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/ photocopy of answer script is 05.09.2014. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
