# **NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the certificate verification, Physical Measurement, Practical test and the result of the Objective Type (OMR Valuation) Test held on **27.07.13** for the post of **Seaman (Category No. 20/09)** on Rs. 4750 – 7820 in **Port Department** in Kollam district for which notification for selection was published in the Gazette dated 12.02.2009 and arranged in the order of merit. This Ranked List is brought into force with effect from 27.08.2014.

The Ranked List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendancy of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The candidates who have secured 35.33 **(Thirty Five point three three)** marks and above in the Objective Type (OMR) Test held on 27.07.13 have been included in the Main List of this Ranked List. The requisite marks have been lowered to the extent necessary in respect of candidates under the reservation group of communities.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be rechecked, to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers if the candidates apply for rechecking, remitting the prescribed fee of Rs.<u>50/-</u> (Rupees fifty only) in any one of the Treasuries in the State under the Head of Account "**0051 PSC 105 State PSC 99 Examination Fee**".

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. The application for rechecking along with the original chalan receipt should reach the District Officer , Kerala Public Service Commission District Office, Kollam within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission). Application for rechecking received after the prescribed time limit(i.e after 10.10.2014) or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and

the result of the rechecking will be intimated to the candidates from this office. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the Treasuries in the State under the Head of Account 0051-PSC-800-Other receipts-99 Other receipts. The duly filled up application in the prescribed form (available on the Commission's Website www.keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, KPSC District Office, Kollam within 45 days from the date on which the Ranked List has come into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

# The last date for the receipt of applications for rechecking/obtaining Photocopy of the answer scripts is 10.10.2014. Application for rechecking/obtaining Photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Candidates whose Register Numbers are not included in the ranked list are advised to refer to Notification No. ERVII(2)8613/13/EW dated 03.04.2014 for the Register Number of invalidated answer scripts and the reasons thereof.

Entries put in Column 8 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Kollam within 1(one) month from the date of publication of the ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in this list

Note:- Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised".
