Entries put in column 8 are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whose communities have not been correctly noted in this list as proved by them in their application should intimate the fact to the Deputy Secretary (Examinations-I), Kerala Public Service Commission, Thiruvananthapuram- 695 004 within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the list.

Note:- Any candidate can relinquish his/her right for appointment in the writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal. The request for relinquishment receive within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
