(6) Candidates belonging to Other Backward Classes/SC/ST included in this list who are required to produce Non – Creamy Layer Certificate/Community certificate as the case may be shall produce the same along with the other documents at the time of verification of original documents.

(7) Copy of answer scripts of the OMR Test held on **28/10/2014** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
