Note 1:

Such candidates in the main list who fail to produce the above mentioned community/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates. As regards such candidates in the Supplementary Lists, their register numbers will be deleted from Short List without further notice
