5. SC candidates included in the Short List are required to produce 2 (Two) copies of Community Certificate issued for production before the Public Service Commission. The Candidates belonging to LC/OBC Communities included in the Short List who are required to produce Non-Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD Dated 29.09.2009 shall produce the same along with the other documents. Such candidates who fail to produce the required Community Certificate/Non Creamy Layer Certificate will be deleted from the Ranked List.

The date , time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer Scripts is not allowed. But candidates can apply for rechecking of their answer scripts after publication of the Ranked List for the post. Detailed instructions will be found in the Ranked list notification for the post.

Copy of the answer scripts of the OMR test held on 14.06.2012 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List.
