**Note 4:**

SC/ST Candidates included in the Short List are required to produce two copies of the Community Certificate issued by the revenue authority and the candidates belonging to Other Backward Classes are required to produce the Non Creamy Layer Certificate as per G. O (P) No. 117/08/SC/ST DD dated 19.12.08 or GO (P) No.81/09/SC/ST/ DD dated 26.09.09 along with the documents mentioned above. Such candidates in the main list who fail to produce the above mentioned community/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered open competition candidates. The date, time and place of interview will be intimated in due course.

**Note 5:**

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking/photocopy of their answer scripts within 45 days from the publication of the Ranked List for the post. Detailed instructions will be published in the Ranked List notification for this post.
