The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.
 - 4) The candidates who have secured **67(Sixty Seven)** marks and above are included in the Main List of the Short List. The required marks have been lowered to the extent necessary in respect of the Supplementary Lists.
 - 5) The candidates belonging to the other backward classes included in the short list except SC/ST candidates are required to produce Non-Creamy Layer Certificate as per GO(P) No.81/2009/SC/ST DD dated 26.09.2009 shall produce the same along with other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates. As regard to such candidates in the Supplementary Lists of Other Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate. SC/ST candidates shall produce Caste Certificate obtained from Revenue Authorities not below the rank of Tahsildar as specified in Kerala Gazette along with other documents.
 - 6) The place, date and time of interview will be intimated in due course.

- 7) Register Numbers of candidates whose answer scripts have been invalidated due to various reasons are provided in the notification appended.
- 8) According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts only after publication of the Ranked List. The details will be published along with the Ranked List.
