Note (6) : As per notification ER II (3) 75/13 EW, ER II (3) 177/13/EW dated 18/06/14 answer scripts of no candidates are invalidated for this post.

Note (7): According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked and photocopy of answer scripts will be issued after the publication of ranked list if applied as per rules.
