Note: In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications:

- I Pass in SSLC Examination or possession of any of the other equivalent qualification.
- II Must possess

(1) ITI (Surveyor Trade) certificate.

OR

- (2) A pass in Surveying and Levelling (Higher) MGTE or KGTE with Chain Survey Test OR
- (3) Experience in Military Service for a period of six years in Surveyor Trade.

Note: 1. In the absence of candidates with the Technical qualifications mentioned above, a pass in Higher Survey Test shall be deemed sufficient

2. In the absence of candidates with any of the Technical Qualifications mentioned above a pass in Chain Survey Test shall be deemed qualified.

Note: Part II Rule 10(a)ii of KS&SSR regarding qualification is applicable for this selection.
