Main Rotation stands at MR I 79 OC, already filled, to be continued from MR I 80 M.

Rotation is worked out in the ratio 1:1 for By Transfer and Direct Recruitment. Since the previous rotation stands at a 'By Transfer' turn, the present rotation started from a 'Direct Recruitment' turn. Therefore out of 4 (Four) fresh vacancies to be filled, rotation for 2 (Two) fresh vacancies for direct recruitment and one DA vacancy is worked out first. Then rotation for remaining 2 (Two) By Transfer turns is worked out.

DA Sl. No. stands at 42 to be continued from 43. (Low Vision, Hearing Impairment and Locomotor Disability are eligible). In the previous selection, One Ortho candidate was advised against Sl. No. 33 (During the previous selection only Locomotor disability candidates were eligible). In accordance with Circular 5/17, DA Sl. Nos changed as 1, 34 & 67 and Sl. No. 43 is now compensated for Sl. No. 34. Being the First DA turn that arose after Circular No. 5/17, the same is given to DA – Low Vision.
