**Note:-**

- (1) The genuineness of the certificate will be subjected to verification and if found bogus, legal action will be taken against the authorities who issued and the candidates who produce the certificate .
- (2) The experience certificate produced from institution other than Government should be got countersigned by the controlling authority/Administrative authority of the Government Department who is authorised to inspect the institution

**6 Age limit :** (1) For Recruitment By – Transfer: No upper age limit is prescribed for recruitment By-Transfer

(2) For Direct Recritment: 22-40. Only candidates born between 02.01.1979 and 01.01.1997 (both dates included) are eligible to apply. Usual relaxation in upper age limit shall be allowed to SC/ST/OBC Candidates

**(For conditions regarding age relaxation please see Para (2) of the General Conditions in Part II of the Gazetee Notification)**

**7 Qualifications :** **For Recruitment By-Transfer and Direct Recruitment**

(1) Masters Degree in the concerned subject or discipline with atleast 50% marks or its equivalent and good Academic records. (G.O(P)No.115/2008/H.Edn.Dated:27.09.2008)

(2) M.ED Degree with not less than 55 % marks (G.O(P)No.102/2011/H.Edn.Dated:19.07.2011)

(3) Three years teaching experience in Schools or Colleges after acquiring the Professional qualification.

(4) Must have passed the comprehensive test specifically conducted for

the purpose by UGC or any agency duly constituted by the State Government in this behalf. When qualifications are being equal preference shall be given to candidates who possess adequate knowledge in Malayalam.

**Note:-**

- (1) Rule 10(a)(ii) of Part II of KS & SSR is applicable.
- (2) The qualifications prescribed for appointment to various categories under the heading, "Class II Training Colleges", in special Rules shall stand revised in accordance with that fixed by the UGC/State Government from time to time.
- (3) The Educational qualification prescribed shall not be insisted in the case of those who were in service before that date of publication of the Kerala Collegiate Education Service(Amendment) Special Rules,2008.
- (4) For Recruitment to various posts of lecturers Degrees awarded by the Universities recognized by UGC alone shall be considered.
- (5) Candidates who claim equivalent Qualification instead of qualification mentioned in the notification shall produce the relevant Government order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned
- (6) In the case of difference in original caste/community claimed in the application and that entered in SSLC book ,the candidates shall produce a Gazette Notification in this regard,along with NCLC/Community Certificate at the time of Certificate Verification.

**Exemptions:-**

1. The Candidates who have passed M.Phil Degree by 31.12.1993 are exempted from possession of NET. (GO(P)No.123/2002/H.Edn.Dated:17.09.2002)
2. The Candidates having Ph.D Degree in the concerned subject are exempted from NET(GO(P)No.86/07/H.Edn.Dated:19.06.2007)

**Reservation:-**

Rules of reservation provided under rules 14 to 17 of part II of KS & SSR 1958 are not applicable in the case of Recruitment By-Transfer.

**8 Mode of Submitting applications**

- a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration card** in

their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, age etc. have to be produced as and when called for.

- b) If written ,/OMR/Online Test is conducted as part of this selection candidates shall submit a confirmation on writing the examination through their One Time Registration profiles . Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test.The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely . The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it
