NOTIFICATION

The following are the list of candidates who have secured 40% marks in the Eligibility Test held on 28.04.2015 for Typist/Confidential Assistant/Non-Graduate Assistant/Office Superintendent for promotion as Section officer in Kerala Govt. Secretariat /Kerala Public Service Commission/Advocate General Office/University (Category No - 150/13) notified in the Gazette dated 09/07/2013. The Register Numbers are arranged in their numerical sequence and this arrangement does not in any way indicate their respective rank on the basis of the OMR Test.

According to the existing procedure, revaluation of answer script is not allowed but answer script will be rechecked if the candidates apply for it in the prescribed application alongwith a chalan receipt for the prescribed fee of Rs 75/- (Rupees seventy five only) remitted in any of the Treasuries in the state under the head of account "0051 PSC 105 State PSC 99 Examination Fee", addressed to the Joint Secretary, Departmental Test Wing, KPSC, Pattom, Thiruvananthapuram – 695 004. Valid application for rechecking should reach the office within 30 days from the date of publication of Eligibility List. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

Application for rechecking of answer scripts should be submitted in the prescribed form (downloaded form printed in A4 size paper) from Commission's website <u>www.keralapsc.gov.in</u>. Applications submitted in any other manner will not be considered. The result of rechecking of candidates who apply as per rules will be intimated from this office.

Candidates who wish to obtain a photocopy of their OMR sheet (Part A & Part B) relating to this selection shall remit the fee of Rs 200/- (Rupees two hundred only) in any treasury (Head of Account "0051-PSC-800-State PSC-99-Other Receipts") and apply in the prescribed form downloaded from the Commissions website <u>www.keralapsc.gov.in</u> alongwith the chalan receipt should be submitted to The Joint Secretary, Departmental Test Wing within 30 days from the date of Eligibility brought into force. Application for his/her own answer script only will be entertained. A copy of answer sheet will be issued only once to a candidate.
