Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to SC/ST Communities are required to produce Community Certificate issued by the Revenue authority and Other Backward Classes are required to produce Non-Creamy Layer Certificate as per existing rules at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-04-2018** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ERX111(2)5410/18/EW dated 09/04/2019.
