Note :- (6) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of OTR verification of original documents. SC/ST candidates shall produce Community Certificate obtained from Revenue Authorities not below the rank of Tahsildar as per Sub Rule (1) of Kerala (SC&ST) Regulation of Issue of Community Certificate Rules 2002.

Note :- (7) Copy of answer scripts of the OMR Test held on **26.06.2018** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
