NOTIFICATION

The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Test held on 28.06.2017 for selection to the post of **Computer Grade II on 10,480-18,300/-(PR) in Printing Department in Thiruvananthapuram District** and arranged in the order of merit. The Ranked List is brought into force with effect from 11.06.2019.

. The Ranked List will remain in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The entries put in column 8 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Pattom P.O, Thiruvananthapuram within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But re-checking of marks will be done on payment of Rs. 85/-(Rupees Eighty five only). The fee should be remitted in any one of the treasuries in the State under the head of account “**0051 PSC - 105 State PSC- 99 Examination Fee**” and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website/ www.keralapsc.gov.in / or photocopied therefrom. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-checking should reach the **District Officer, K.P.S.C District Office, Pattom P.O, Thiruvananthapuram** within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.335/- (Rupees Three hundred and thirty five only) by way of chalan in any of the treasuries in the State (Head of Account **0051 PSC-800 State PSC - 99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should be submitted to the **District Officer, K.P.S.C District Office, Pattom P.O, Thiruvananthapuram** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.”

The A part and B part of OMR script will be destroyed after completing 6 months period from the date of finalisation of Ranked List ie 10/12/19.

Valid applications for rechecking/ photocopy of answer script addressed to **District Officer, K.P.S.C District Office, Pattom P.O, Thiruvananthapuram** shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/ photocopy of answer script is 25.07.2019. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.

NOTES FOR APPROVAL OF THE RANKED LIST

Sub: Field Worker in Health Services Department – Tvpdm District (Cat.No.416/13) – Ranked List – Approval – Reg:-

(1) The post of Field Worker in Health Services Department on Rs.8730-13540/- in Thiruvananthapuram District was notified in the Gazette dated 15.11.2013 as Category No. 416/13.

(2) The Qualification prescribed for the post is as follows.

(1) Must have studied up to VIII standard or its equivalent

(2) Should have good physique and must be free from physical deformity and diseases of any description.

Note:- (1) Physical fitness shall be certified by a Medical Officer not below the rank of an Assistant Surgeon.

(2) Physically handicapped persons are not eligible to apply for the post.

(3) Concession for Physically Handicapped Candidates contemplated in para 2 and 5 of the General Conditions are not applicable for selection to this post.

(3) Age Limit: - 18-36. Only candidates born between 02.01.1977 and 01.01.1995 (Both dates included) are eligible to apply for this post with usual relaxation to SC/ST and OBC.

(4) The last date for receipt of application was on 18/12/2013. A total number of 51983 applications were received for the post. An OMR test was conducted on 10.01.2015. A probability list No. 53/16/Dot for the above post was published on 23.11.2016 by including 266 candidates in the Main List and 201 candidates in the Supplementary Lists. These candidates were called for One Time Verification which was held from 06.02.2017 to 10.02.2017 and for the absentees on 23.02.2017. A total number of 264 candidates were present for Certificate Verification and 203 candidates were absent for the Certificate Verification. After detailed scrutiny 262 applications were admitted and 205 application were rejected since they did not turned up for OTV.

(5) Weightage Marks of 9 is awarded to Sri.Biju (Reg.No.142179) for being an Ex-Servicemen for 18years)

(6) Marks were awarded for sports to 3 candidates having Register Number 118773 (Aswan.V S) – 14.25, Reg.No. 118774 (Ashok V S) – 14.25, Reg.No. 115560 (Sruthy V M) – 23.75.
