Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010 and also bear the name of candidate and the date of photo taken. The uploaded photo will be having a validity of ten years from the date of photograph taken.

Note:- The above Vacancy is now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years, provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Caste/Scheduled Tribe during the pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribes for vacancies reserved exclusively for them will be issued.

5 Method of Appointment : Direct Recruitment (Special Recruitment from Scheduled

Castes/Scheduled Tribes).

Note:- Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 Age : 18-41

(Only Candidates born between 02.01.1978 and

01.01.2001 (both dates included) are eligible to apply for this

post) No other age relaxation will be allowed.

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications

(1) Graduation from a recognized University in India

Conditions of appointment:

1. The Candidates recruited will be governed by the provisions in the General and Special Rules of

Treasury Services with regard to the commencement, completion, extension, termination and suspension of probation. For the first six months of the probation the candidate will be required to undergo, such training as the Director may prescribe.

- 2. The candidate will have to acquire the following Department Tests during the period of probation.
 - (a) Test on M.O.P.
 - (b) Treasury Test (Higher)/Account Test (Higher)
- 3. The candidates will be declared to have completed the probation only if he/She acquires the aforesaid Departmental Test and if his/her performance during the period of probation is satisfactory.
- 4. The candidate will be considered according to his/her turn for appointment to higher categories in the department only after successful completion of probation.

Note 1) Rule 10 (a) (ii) of Part II KS&SSR is applicable for this selection.

- 2) Those candidates who have claimed equivalency for qualifications should produce the Government order proving the same at the time of certificate verification in order to consider as equivalent.
- 3) If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce Community Certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. AApplication once submitted is treated as provisional and cannot be deleted or altered The application will be summarily rejected if after the last date of receipt of application. noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. The profile correction made by the candidate or in the office of the Kerala Public Service Commission on request after the last date fixed for receipt of application will not be reflected in the application. Such corrections will be in effect on the date on which corrections have been made. Those who have Aadhaar Card should add Aadhaar Card as ID Proof in their profile.
