**THIRD NCA NOTIFICATION**

Applications are invited through One Time Registration Scheme by Online from qualified candidates belonging to Reservation Group of community in Kerala mentioned below for selection to the undermentioned post in Kerala Government Service.

1.	<b>Department</b>	:	<b>Health Service</b>
2.	<b>Name of Post</b>	:	<b>Assistant Surgeon/Casualty Medical Officer</b>
3.	<b>Scale of pay</b>	:	<b>Rs.45800-89000/-</b>
4.	<b>Number of vacancy</b>	:	<b>Scheduled Caste Converts to Christianity (SCCC)-25</b>

The above vacancies are now in existence. The Ranked list published by the Commission as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for **SCCC community** but remain unfilled due to the paucity of the candidates during the currency of the Ranked List published on **25.03.2013** for the post (**Category No.567/2012, Gazette Date:19.11.2012**). This is the **Third NCA Notification** published due to the non-availability of sufficient candidates belonging to the SCCC community for the post as per **first NCA Notification dated:26.12.2014 (Category No.597/2014)** and **second NCA Notification dated:30.12.2016 (Category No.485/2016)**.

**Note I :** Those who are appointed in the post should serve for four (4) years during the first ten years of their service (including the period of training) anywhere in India or any other foreign country under Defence Service or Services connected with Defence , if required. Those who have completed forty five (45) years of age are exempted from the above compulsory military service.

**Note II :** As per GO(P) No.61/12/SWD dated:17.10.2012 Differently Abled candidates with Locomotor Disability/Cerebral palsy,Hearing impairment are identified as suitable for appointment to this post. Hence Differently Abled candidates with Blindness/Low Vision are not eligible to apply for this post.

**5.Method of appointment:**Direct Recruitment (from candidates belonging to SCCC community only)

**Note:** Applications submitted by candidates belonging to communities other than SCCC community will be summarily rejected. No rejection memo will be issued to such applications.

**6.Age limit:** 18-45 ; Only candidates born between 02.01.1974 and 01.01.2001 (both dates included) are only eligible to apply [including the relaxation as per para (2) (i) of the General Conditions]

**Note:** For candidates belonging to SCCC community , members belonging to Scheduled Caste who had converted to Christianity after attaining adulthood and their children are eligible for age relaxation up to 47 years. Such candidates should be born between 02.01.1972 and 01.01.2001 (both dates included).

(For conditions regarding age relaxation see Para 2 of the General Conditions except 2(i) )

### **7.Qualifications:**

1. Degree in Modern Medicine (MBBS) or equivalent qualifications

2.Valid Registration with Travancore-Cochin Medical Council.

**Note I :**For persons who were in Defence Service , the first one year of their service will be treated as House Surgency.

**Note II:** Personnel working in various departments of Government and acquired MBBS qualification while in service will be given exemption from upper age limit to the extent necessary for Direct Recruitment. The maximum age limit shall in no case exceed 50 years.

**Note III:**Candidates who claim equivalent Qualifications instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification,then only such qualifications shall be treated as equivalent to the prescribed qualification .

**Note IV:** In the case of difference in original caste /community claimed in the application and that entered in S.S.L.C book, the candidate shall produce a Gazette Notification in this regard , along with Non Creamy Layer Certificate/Community certificate at the time of Certificate Verification.

**Note V:** KS&SSR Part II Rule 10(a) (ii) is applicable.

### **8. Mode of submitting Application:-**

- a. Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final

submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for.

- b. If a Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation on writing the examination through their one time registration profile. Such candidates alone can generate and download the admission tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in their mobile phones registered in it.
- c. Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
