NOTIFICATION

The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Test held on 04.04.2018 and Practical Test held from 11.06.2019 to 13.06.2019 for selection to the post of Driver (Part I) on Rs.19000 – 43600/- in Excise Department in Kannur District (Cat No. 659/2017) notified in the Gazette dated 30.12.2017 and arranged in the order of merit. The Ranked List is brought into force with effect from 04.09.2019.

Since a Common Test/OMR Test with common candidates was conducted for the post, the marks awarded to the candidates included in this Ranked List and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA notifications) which will be finalised on the basis of the common test.

The Ranked List shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new Ranked List after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. In case no candidate is advised from the rank list during its term it shall be extended for a further period of one year or till atleast one candidate is advised from the list whichever is earlier. Candidates from this list will be advised for appointment against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointment on the basis of the inclusion of their names in the list.

Entries put in Column 9 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Civil Station PO, Kannur, 670 002 within 1 (one) month from the date of publication of the ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in this list.

According to the existing procedure, re-valuation of answer script is not allowed. But answer scripts will be rechecked to see that all the answers are valued and that there is no mistake in the totalling of marks for various answers if the candidate apply for rechecking remitting the prescribed fee of Rs. 85/-(Rupees Eighty Five Only) in any one of the Treasuries in the State under the Head of Account '0051 PSC-105 State PSC- 99 Examination Fee' and original chalan should be enclosed with the application. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website/ www.keralapsc. gov.in / or photocopied there from.

Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the District Officer, K.P.S.C. District Office, Civil Station PO, Kannur 670 002 within 45 days (ie on 18/10/2019) from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account. Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 335/- (Rupees Three Hundred and Thirty Five Only) by way of chalan in any of the Treasuries in the State under the Head of Account 0051 PSC-800-State PSC-99 Other receipts. The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the District Officer, KPSC District Office, Civil Station PO, Kannur 670 002 within 45 days (ie on 18/10/2019) from the date on which the ranked list is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions". The request for relinquishment received within 15 days from the date of publication of the Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

The A part and B part of OMR Script will be destroyed after completing, 6 months period from the date of finalisation of Ranked List ie, on 03.03.2020.

Valid Applications for rechecking/photocopy of answer script along with the original chalan receipt addressed to the District Officer, Kerala Public Service Commission District Office, Civil Station PO, Kannur, 670 002 shall reach this office within 45 days (ie on 18/10/2019) from the date on which the Ranked List is brought into force (i.e, the date on which the Ranked List has been approved by the Commission). The last date for receipt of applications for rechecking/photocopy of answer script is 18.10.2019. Application for rechecking/photo copy received after the prescribed time limit and not in the prescribed form will not be entertained.
