NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR valuation) Test held on 04.02.2017 and verification of original documents of the candidates included in the Probability List, published on 02/08/2019 for selection to the post of **Laboratory Assistant (SR for SC/ST & ST only) (Category No. 363/2016)** on Rs. 17500-39500/- in **Kerala Higher Secondary Education Department in Thrissur District** notified in the Gazette dated 11/11/2016 arranged in the order of merit. A common objective type (OMR valuation) test was held on 04/02/2017. Hence marks secured by the candidates included in the Ranked List are hidden. The Ranked List is brought into force with effect from **03.09.2019**.

The Ranked List of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of minimum period of one year is published. Candidates from the list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointments on the basis of the inclusion of their names in the list.

Recruitment will be made for the vacancies reported for Special Recruitment from Scheduled Castes/Scheduled Tribes during the pendency of the list. Candidates against vacancies reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list, fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be rechecked, to see that all the answers are valued and that there is no mistake in the totalling of marks for various answers if the candidates apply for rechecking, remitting the prescribed fee of Rs. **85/-** (Rupees Eighty Five only) in any one of the Treasuries in the State by chalan under the Head of Account **“0051 PSC 105 STATE PSC-99 EXAMINATION FEE”**.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website: www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. The applications for rechecking of answer script along with the original chalan receipt should reach District Officer, Kerala Public Service Commission District office Thrissur, within 45 days from the date on which this Ranked List has come into force. (i.e. the date on which the Ranked List has been approved by the Commission.) Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above. The marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office. Application for rechecking received from the candidates whose answer scripts have been invalidated will not be considered.

Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and B) relating to this selection shall remit the fees of ` **335/-** (Rupees Three Hundred and Thirty five only) in any one of the Treasuries in the State by chalan under the Head of Account **0051-PSC-800- STATE PSC - 99 Other receipts**. The duly filled up applications in the prescribed form (available from the commission's [website www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chalan should be submitted to the District Officer, K.P.S.C District Office, Thrissur within 45(forty five) days from the date on which this Ranked List has come into force(i.e. the date on which the Ranked List has been approved by the Commission). A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The last date for receipt of application for rechecking/obtaining photo copy of answer scripts is **17.10.2019**. Application for rechecking/obtaining photo copy received after the prescribed time limit or not in the prescribed form will not be entertained.

Entries put in column 8 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Thrissur within 1(one) month from the date of publication of the Ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

“Any candidate can relinquish his right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal along with a notarized affidavit and self attested copy of ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official web site of the commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request of relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he is to be advised.”

A part and B part of the OMR script will be destroyed after completing 6 months period from the date of finalisation of the Ranked List that is on 02.03.2020.
