Application for rechecking recieved after the stipulated time will not be entertained and fee once remitted will not be refunded.
- (3) "Any candidate can relinquish his/her right for appointment in writing duly attested by Gazetted Officer of the State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affadavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of ranked list. After the publication of ranked list, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".
- (4) Since a common Written Test/OMR test with common candidates for other posts was conducted for this post, the marks awarded to the candidates included in this Ranked List will be published only after publication of all other posts for which common test was conducted
