- (ii) Separate Ranked Lists will be prepared for Alapuzha District in pursuance of this notification. The Ranked list published for this post shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will continue to be in force till the publication of a new list for this district after the expiry of of three years. Candidates will be advised from the said list against the vacancies noted above and the vacancies that may be reported to the Commission in writing during the period of currency of the Ranked List. In case no candidate is advised from the ranked list till the expiry of three years the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(Ms.) No.04/61/PD dated, 02.01.1961 for inter district transfers. Candidates already in Government service holding this post in any one district are prohibited from applying in response to this notification.
