The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for Other Backward community as unfilled due to the paucity of candidates during the currency of Ranked List published on 30.03.2011 (Cat.No:276/10), Gazette Date: 27.10.2010) for the post. This is the III NCA notification for the post owing to the non availability of qualified candidates belonging to the above mentioned community as per the first (Cat.No:699/12, Gazette dated 31.12.2012) and Second (Cat. No:566/15, Gazette dated 29.12.2015) NCA Notifications.

5. Method of appointment

: Direct Recruitment from among candidates belonging to Other Backward community only Note:- application of candidates belonging to community other than Other Backward community will be summarily rejected. Individual rejection memo will not be issued to them.

6. Age limit

: 18 – 45: only candidates born between 02.01.1974 and 01.01.2001 (both dates are included) are eligible to apply for the post (Including the age relexation as per para 2(i) of the General conditions). For other conditions regarding age relaxation please see Para 2 of General Conditions except para 2(i)

7. Qualifications:-

- 1. Degree in Modern Medicine (MBBS) or equivalent qualification.
- 2. Post Graduate Degree/Diploma in concerned specialty or equivalent qualification.

OR

Diplomate in National Board in concerned specialty. Note I:- Preference will be given in direct recruitment to candidates with Post Graduate Degree or Super Specialty Degree over those with Post Graduate Diploma qualifications, if other things being equal. Note II:-(1) Degree /Post Graduate Diploma/Post Graduate Degree/super specialty Degree wherever mentioned in this notification must be either awarded or recognized by any recognized University or equivalent Institute. Medical Degree/ Post Graduate eguivalent Degree/Diploma or qualification recognized by Medical Council of India and Diplomate in National Board awarded by National Board of Examinations only will be considered. Non Degree or Diploma mentioned in this notification must be awarded by any recognized University or equivalent Institution.

- (2) Equivalent Medical qualification wherever mentioned in this notification (except DNB) means those qualification recognized as equivalent by the Medical Council of India.
- 3. Valid Registration with Travancore-Cochin Medical Council.

Note(a): KS & SSR Part II Rule 10(a)(ii) is applicable

**Note(b)**: Candidates who claim equivalent qualifications instead of qualification mentioned in the Notification shall produce the relevant government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

**Note (c):** In the case of difference in original Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of Certificate Verification.

## 8) Mode of submitting Application:-

a) Candidates must register as per "ONE TIME REGISTRATION" system on the official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded in the profile should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered

after submission. The applications submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.

- **b)** If written/OMR/Online Test is conducted as part of this selection candidates shall submit a conformation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit conformation within the stipulated period, will be rejected absolutely.
