 - District Office of the Kerala Public Service Commisssion, Thiruvananthapuram. Therefore the candidate who are selected in pursuance of the notification must be willing to work anywhere in the state if posted.
- iii) The above vacancy is now in existence. The Ranked List thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancy and also against the vacancies, if any, reported during the currency of the list. In case no candidates is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

6 Age Limit : 18-36 Only candidates born between 02.01.1983 and

01.01.2001 (both dates included) only are eligible to apply for this post. Other Backward Communities and SC/ST candidates are eligible for usual age relaxation.

For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years of age, please see para 2 of general condition under Part II of this notification.

7. Qualifications:-

- 1 Ability to Read and Write in malayalam or Tamil or Kannada.
- 2 National Trade Certificate in Carpentry(ITI) or Equivalent.

Note:-

- i) K.S & S.S.R Part II Rule 10a(ii) is applicable for selection to this post..
- ii) Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of One Time Verification or as required by the Commission
- iii) 3% of the fresh vacancies are reserved for differently abled candidates belonging to Locomotor disability/ Cerebral Palsy, Hearing impairment categories as per G.O(P)No.1/13/SJD dated 03.01.2013. Differently abled candidates with blindness/Lowvision category are not eligible to apply for the post as these categories are not identified for 3% reservation.

Candidates must register as per "ONE TIME REGISTRATION" with the website Kerala of **Public** Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to this profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded in the profile should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion in white background. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of taking Photograph. No application fee is required. Candidates can view and have a print out of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the

final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote the User ID for further communication with the Commission. Applications submitted is provisional and cannot be deleted or altered after submission.
