Applications are invited from qualified Ex-servicemen of Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after ONE TIME REGISTRATION. Candidates who have already registered can apply through their profile.

- 1 Name of Department** : Sainik Welfare Department
- 2 Name of post** : Last Grade Servants (Special Recruitment from among Ex-servicemen of ST only)
- 3 Scale of pay** : Rs 8500-13210 (PR)
- 4 No. of Vacancy** : District wise  
**Thiruvananthapuram -(Special Recruitment for Ex-servicemen ST only -1)**

**Note:(i)** The above Vacancy is now in existence. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled Tribes from Sainik Welfare Department during the currency of the list.

**(ii)** The selection in pursuance of this notification will be made on a Revenue District basis subject to the Special conditions laid down in G.O (MS)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List so prepared is not eligible for transfer to another District unless he/she completes five (5) years continuous service from the date of commencement of service in the former District. Even if, transfer is allowed after five (5) years, it will be subject to the orders contained in G O (Ms) No.4/61/PD dated 2.1.1961. Candidates already in Government Service, holding the post in any one District are restricted from applying for the same post in another District. But they can apply for higher posts.

**(iii)** Candidates from the Ranked List for districtwise selection will be advised for appointment against the Head quarters vacancies also. As per the provision in G.O(Ms)154/71/PD dated 27.05.1971 appointment against the Headquarters vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.

- 5 Method of Appointment** : Direct Recruitment  
(Special Recruitment from among Ex-servicemen of Scheduled Tribes only).

**Note:-** Applications received from candidates other than Ex-servicemen of Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

**6 Age : 18 – 50**  
Only Candidates born between 02/01/1969 and 01/01/2001 (both dates included, inclusive of the period of Military Service)) are eligible to apply for this post.

**Note :** 1. But in no case the maximum age limit shall exceed 50 (fifty) years.  
2. For details regarding age relaxation please see the General Conditions given in part II of this Notification.

**7 Qualifications:**

Must have passed standard VII and must not have acquired graduation.

**Note:(i)** Part II Rule 10(a)ii of KS&SSR regarding qualification is applicable for this selection.

**(ii)** Those candidates who have claimed equivalency for qualifications should produce the Government order proving the same at the time of certificate verification in order to consider as equivalent.

**(iii)** Physically handicapped candidates and female candidates are not eligible for appointment to the post of Watcher, Night Watcher, Watchman and Night Watchman.

**(iv)** Only one common Ranked List will be prepared for the various posts included in the Last Grade Service.

**(v)** If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

**8 Mode of Submitting application:**

a) Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link for applying for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the

notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

b) "Candidates who have AADHAAR Card should add AADHAAR Card as I.D proof in their profile".

c) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile, such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

d) Candidates who have claimed bogus information about qualification and experience in application , and will/ willn't attend the examination after given confirmation, disciplinary action will be taken against him/her as per Rules of Procedure of Rule 22

**12** Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
